The midlandsimon.com website is owned and operated by Midlands Simon Community, a company registered under the laws of Ireland Reg No 371956 and as a registered charity CHY NO. 15508.

By using the midlandsimon.com website or contacting us via the website or donating to midlandsimon.com, users agree to be bound by the following terms and conditions.

In these terms and conditions, the following definitions shall apply:
